PRIVACY POLICY

Protecting your private information is our priority. This Statement of Privacy applies to <https://agcsd.org>, and AGC San Diego Chapter, Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to AGC San Diego Chapter, Inc. include <https://agcsd.org> and AGC San Diego Chapter. The AGC San Diego Chapter website is the association website for its members to find information, view membership details, and register for events and training classes. By using the AGC San Diego Chapter website you consent to the data practices described in this statement.

COLLECTION OF YOUR PERSONAL INFORMATION

In order to better provide you with products and services offered, AGC San Diego may collect personally identifiable information, such as your:

- Full Name
- Mailing Address
- Email Address
- Phone Number
- Employer
- Job Title

If you purchase AGC San Diego Chapter's memberships, events, or classes, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account to the member portal; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We may also gather additional personal or non-personal information in the future.

USE OF YOUR PERSONAL INFORMATION

AGC San Diego Chapter collects and uses your personal information to operate and deliver the services you have requested.

AGC San Diego Chapter may also use your personally identifiable information to inform you of other products or services available from AGC San Diego Chapter and its affiliates.

SHARING INFORMATION WITH THIRD PARTIES

AGC San Diego Chapter does not sell, rent, or lease its customer lists to third parties.

AGC San Diego Chapter may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to AGC San Diego Chapter, and they are required to maintain the confidentiality of your information.

AGC San Diego Chapter may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on AGC San Diego Chapter or the site; (b) protect and defend the rights or property of AGC San Diego Chapter; and/or (c) act under exigent circumstances to protect the personal safety of users of AGC San Diego Chapter, or the public.

TRACKING USER BEHAVIOR

AGC San Diego may keep track of the websites and pages our users visit within <https://agcsd.org>, in order to determine what AGC San Diego Chapter services are the most popular. This data is used to deliver customized content and advertising within AGC San Diego Chapter and its website to customers whose behavior indicates that they have interest in a particular subject area.

AUTOMATICALLY COLLECTED INFORMATION

Information about your computer hardware and software may be automatically collected by AGC San Diego Chapter. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the AGC San Diego Chapter website.

USE OF COOKIES

The AGC San Diego Chapter website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the web server that you have returned to a specific page. For example, if you register with AGC San Diego Chapter or services, a cookie helps AGC San Diego Chapter to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing address, shipping address and so on. When you return to the same AGC San Diego website, the information you previously provided can be retrieved, so you can easily use the AGC San Diego Chapter features that you customized.

You have the ability to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline

cookies, you may not be able to fully experience the interactive features of the AGC San Diego Chapter services or websites you visit.

SECURITY OF YOUR PERSONAL INFORMATION

AGC San Diego Chapter secures your personal information from unauthorized access, use, or disclosure. AGC San Diego Chapter utilizes a combination of online and offline security technologies, procedures, and organizational measures to help safeguard personal data. For example, facility security is designed to prevent unauthorized access to AGC San Diego Chapter computers. Electronic security measures – including, for example, network access controls, passwords, and access logging – provide protection from hacking and other unauthorized access. AGC San Diego Chapter also protects personal data through the use of firewalls, role-based restrictions and, where appropriate, encryption technology. AGC San Diego Chapter limits access to personal data to employees, subcontractors, and third-party agents that have a specific business reason for accessing such personal data. Individuals granted access to personal data are aware of their responsibilities to protect such information and are provided appropriate training and instruction.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations inherent to the Internet which are beyond our control; and (b) security, integrity, and privacy of any and all information and data exchanged between you and us through this site cannot be guaranteed.

RIGHT TO DELETION

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and
- Direct any service providers to delete your personal information from their records.

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

- Complete the transaction for which the personal information was collected, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity.
- Debug to identify and repair errors that impair existing intended functionality.

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law.
- Comply with the California Electronics Communications Privacy Act.
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent.
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us.
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

CHILDREN UNDER THIRTEEN

AGC San Diego Chapter does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.

EMAIL COMMUNICATIONS

AGC San Diego Chapter may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or general communication. In order to improve our services, we may receive notification because you opened an email from AGC San Diego Chapter or click on a link therein.

If you would like to stop receiving marketing or promotional communications via email from AGC San Diego Chapter, you may opt out of such communication by replying STOP or by clicking the UNSUBSCRIBE link and/or button.

EXTERNAL DATA STORAGE SITES

We may store your data on servers provided by third party hosting vendors with whom we have contracted.

We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified by your account, by placing a prominent notice on your website, and/or by updating any privacy information.
