Take Action Against Government Mandated PLAs

As you know, on February 4, 2022, President Biden signed Executive Order (EO) 14063, which will require **every** federal prime contractor and subcontractor to engage in negotiation or agree to Project Labor Agreements (PLA) on federal construction projects valued at \$35 million or more. This EO will eventually repeal and replace President Obama's own PLA EO in 2009, which *encouraged* the use of PLAs on projects above \$25 million.

The Federal Acquisition Regulation Council has issued a proposed rule opening a public comment period until October 18, 2022. Take action now by visiting [Oppose Government-Mandated Project Labor Agreements \(PLAs\) - Associated General Contractors of America \(agc.org\)](#) and letting the Biden Administration know how this impacts your company.

The White House estimates this EO could impact **\$262 billion in federal construction** and **200,000 workers**. AGC of America CEO, Stephen Sandherr, said the Biden Administration is trying "*to solve a problem that doesn't exist*" and criticized the timing of this order "*at a time when firms are already struggling with labor shortages and skyrocketing materials prices. It also undermines the bipartisan spirit of the new infrastructure bill.*" AGC of America and AGC San Diego both supported the Bipartisan Infrastructure Law.

Back home in San Diego, AGC is leading the charge against **Measure D**. Measure D, if passed, would open the door to discriminatory, union-only, project labor agreements on billions of dollars of City of San Diego projects. CARB: "Oh, Never Mind"

After a decade of making costly engine replacements to meet air-quality regulations, the trucking and construction industries are now being told by the California Air Resources Board (CARB), "Oh, never mind." CARB is now proposing a new set of regulations called the Advanced Clean Fleets Regulation. This after these two industries have spent billions of dollars complying with CARB's present regulatory scheme.

The present rules are called the Truck and Bus Regulation. On-road diesel vehicles with a Gross Vehicle Weight Rating (GVWR) of greater than 14,000 pounds were required under the rules to reduce exhaust emissions by meeting particulate filter requirements and upgrading to newer engines. Vehicles with a 2010 engine model year (EMY) or newer are fully compliant.

Older vehicles had to be upgraded or replaced under the following schedule for GVWR over 26,000 pounds (under 26,000 pounds has a slightly different schedule):

Engine Model Year	PM Filter	2010 EMY by
Pre-1994	Not Required	Jan. 1, 2015
1994-1995	Not Required	Jan. 1, 2016
1996-1999	Jan. 1, 2012	Jan. 1, 2020
2000-2004	Jan. 1, 2013	Jan. 1, 2021
2005 or newer	Jan. 1, 2014	Jan. 1, 2022
2007-2009	If already equipped	Jan. 1, 2023

There also were exemptions in the regulations. For example, low mileage construction vehicles with a particulate matter filter could operate up to 15,000 miles per year without upgrading the EMY per the schedule above, and dump trucks could operate up to 20,000 miles per year. More time to upgrade engines was also available for fleets that installed PM filters in all their vehicles.

As you can see from the replacement schedule above, the truck and construction industries have been spending billions of dollars over the last 12 years bringing their fleets into compliance. The investments into these upgrades by fleet owners are also long-term investments. The assumption by fleet owners is that they are making 25–30-year investments into these commercial vehicles which means that replacing a 2005 engine with a 2010 engine which was required on January 1, 2022 was an investment that was to carry that equipment out to 2052 or so.

Now CARB is saying that the climate crisis is causing them to change the rules and go all-electric. Meaning that the billions of dollars that have been spent on compliance will not get the expected return on investment and billions more will need to be spent on a new regulatory scheme moving forward.

The new proposed Advanced Clean Fleets Regulations are a dramatic departure and amazingly tone deaf to the economic reality of the truck and construction industries. The regulation would apply to fleets performing drayage operations, state and local agencies, federal government agencies, and high priority fleets with at least 1 vehicle with a gross vehicle weight rating (GVWR) greater than 8,500 lbs. operating in California. High priority fleets are defined as an entity with \$50 million or more in gross annual revenue or a fleet who owns, operates, or controls a total of 50 or more vehicles themselves or under

common ownership and control. Only vehicles with a GVWR greater than 8,500 lbs. included in this total. The regulation affects medium- and heavy-duty trucks, off-road yard trucks and light-duty mail and package delivery vehicles.

Regulated fleets must only purchase zero emission vehicles starting in 2024. Lighter vehicles, such as box trucks and yard tractors will have to be replaced with Zero Emission Vehicle(s) (ZEV's) starting at 10 percent of the fleet by 2025 up to 100% by 2035. For heavier vehicles like big rig trucks, 10% of the fleet must be ZEV's by 2030 and 100 percent ZEV's by 2042.

The cost of putting in a charging system at one fleet facility is estimated to be about \$100,000. This does not include the upgrade required by the utility company on their equipment to bring enough electricity to the facility to power the charging system for heavy vehicles. The batteries for a big truck are estimated to weigh 10,000 lbs., which means that an 80,000 lb. rated big rig can haul 15% less goods, so we need 15% more trucks on the road to haul the same goods in California and 15% more drivers. The costs are enormous for this new scheme, not to mention the monumental waste of resources already sunk into these fleets.

They also seem to be oblivious to the fact that, as we are seeing in real time, this past Labor Day, the energy grid in California can't handle the electricity load of today. It will take decades of investment by utility companies to upgrade the systems to meet the new demands of charging electric vehicles being proposed by California.

Electoral Bargaining

Last week, on Labor Day, the Governor signed into law what could end up being a sweeping change to labor relations in the State of California. In the aftermath of the COVID pandemic, the State Legislature has passed several laws to aid in recovering from government mandated closures and restrictions. AB257, known as the *Fast Food Accountability and Standards Recovery Act* or *FAST Recovery Act* specifically targets fast food workers in large chains (100 or locations more nationally).

The *FAST Recovery Act* will create a 10-member panel to “establish sectorwide minimum standards on wages, working hours, and other working conditions related to the health, safety, and welfare of, and supplying the necessary cost of proper living to, fast food restaurant workers, as well as effecting interagency coordination and prompt agency responses in this regard.” ([read full text here](#))

The panel, which will be housed in the Department of Industrial Relations, will have:

- One representative from the Department of Industrial Relations.
- Two representatives of fast food restaurant franchisors.
- Two representatives of fast food restaurant franchisees.
- Two representatives of fast food restaurant employees.
- Two representatives of advocates for fast food restaurant employees.
- One representative from the Governor’s Office of Business and Economic Development.

Each member will serve a 4-year term. One of the main targets of this new panel is a higher minimum wage. California already has the highest minimum wage in the United States as it moved to \$15 an hour (26 or more employees) at the beginning of 2022. However, within the text of the bill is a likely jump to \$22 for those meeting the above standards – fast food, 100 locations. Per the bill text: “Any minimum wage established by the council shall, from January 1, 2023, to December 31, 2023, inclusive, shall not be greater than twenty-two dollars (\$22) per hour.” Beginning January 1, 2024, it could be increased by up to 3.5% annually.

So, why does this matter to construction? Well, the so-called “Fight for \$15” movement to make minimum wage \$15/hour started with fast food and is now the law of the land. But, the bigger picture is this is a major step toward **sectoral bargaining**. Sectoral

bargaining, popular in other parts of the world like France, Belgium, and Austria, shifts collective bargaining to an industry, region, or occupation. In other words, everyone in a particular sector would be covered by the same agreement regardless of where or for whom they actually work. Most of the United States is covered by **enterprise bargaining**, which is specific to one company or one particular worksite. This also continues a trend in this State of elected legislators granting tremendous power to an unelected body.

AGC San Diego will be following this one closely.

New Buy America Requirements on the Way

The U.S. Department of Transportation (USDOT) has temporarily suspended Buy America requirements for certain construction materials needed to build infrastructure projects with federal participation, in part due to challenges in sourcing domestic construction materials and ongoing supply chain issues.



On November 15, 2021, President Biden signed the Infrastructure Investment and Jobs Act into law. A crucial provision in the Act, called Build America, Buy America Act (BABA), imposes broader Buy America requirements for certain construction materials — materials other than items of primarily iron or steel — including stone, sand or gravel, non-ferrous binding agents, plastic- and polymer-based products, glass, lumber, and drywall.

The relevant Buy America requirements became effective on May 14, 2022. The USDOT temporarily suspended those requirements when it issued its [180-day waiver](#) on May 19, 2022. Contractors need to know that the waiver is slated to expire November 10, 2022, so expect that bid solicitations from that day forward will have the BABA requirements added back in.

The suspension of Buy America requirements is affording the USDOT and procuring governmental entities time to develop enforcement and compliance mechanisms for new Buy America standards.

The delay also will allow contractors time to investigate potential domestic sources of certain construction materials and to build up an adequate supply base to support federally funded transportation infrastructure projects.

The USDOT agreed that public interest waivers should be used sparingly and concluded that avoiding the disruption to civil infrastructure (particularly transportation and transit) projects constitutes a rare and appropriate use of the authority.

Generally, Buy America requires that all iron and steel, manufactured products, and construction materials used in federally funded/federal-participation infrastructure projects must be produced in the United States. Buy America requirements are largely observed by contractors and subcontractors, project sponsors, builders, and design and construction professionals. The White House provided preliminary guidance in an [OMB Memorandum](#) published on April 18, 2022, highlighting that a public interest waiver may

be appropriate where a procuring agency determines that the Buy America requirements are inconsistent with other important policy goals.



State Construction Stormwater Permit Adopted

On September 8, 2022, the California State Water Resources Control Board approved the Construction General Permit (CGP), an NPDES permit regulating stormwater discharges from construction sites. This was after about three years of deliberation, stakeholder meetings and receiving public comments. The vote on September 8, to approve the new permit was 4-0 with one Board member not in attendance. The Water Board seemed to back off the most onerous requirements in the proposed new permit, literally at the last moment.

The current permit was approved in 2009 and became effective in 2010. However, because of a legal challenge by the building and construction industry, the permit was revised, and the amended version went into effect in 2012. The same group of construction industry experts who challenged the 2010 permit were at the recent adoption hearing as were the same environmental justice warriors from non-government organizations (NGO's) like the Coastkeeper and the National Resource Defense Council. The staff, most of whom were probably in middle school in 2010, proposed the nearly identical permit requirements that were challenged in 2010 and set aside by the court. It seems obvious to this observer, that the NGO's have powerful sway over the Water Board staff and only the threat of another legal challenge backed them off.

The construction industry, represented by several collaborating coalitions, worked hard to educate the Water Board's staff, board members and the Newsom administration about some problematic portions of the new CGP. The final approved permit went through numerous changes – even as recently as the day of hearing. Most of those changes occurred due to concerns raised by the building and construction industry.

The new permit will go into effect on September 1, 2023. However, for those projects that secure coverage under the current permit (2012 permit) prior to September 1, 2023, that coverage will last for two years after the effective date (September 1, 2025). This is by default a 2-year permit grandfathering clause. As previously mentioned, the building and construction industry coalition secured several procedural changes to the proposed permit that were necessary to keep compliance costs of the new permit down.

Over the last three years of deliberations the primary issue of concern with the permit was the inclusion of numeric effluent limits (NELs). The construction industry had success in removing almost all NELs from the permit and for the remaining NELs the State Water Board incorporated a reopener provision allowing stakeholders to generate data that industry experts believe will assist the building and construction industry in pushing back on the remaining NELs before they go into effect.

The original NEL's proposal by the State Water Board three years ago by staff were to include 69 NEL's for various polluted waterbodies throughout California. In the final permit, the only NELs that will go into effect when the permit becomes effective apply to four specific lakes in the Los Angeles region (Echo Park Lake, Legg Lakes, Peck Road Park Lake, and Puddingstone Reservoir) and in those cases are dealing with pesticide compounds only.

However, it is important to note – as mentioned previously – that the State Water Board included a re-opener for these NELs and that an update is required by August 2023 (prior to the effective date of the permit). The remaining NELs (zinc, lead, copper e.g.) for these four lakes as well as the NELs for the Dominguez Channel and the need to comply with the NELs do not kick in until March 23, 2032.

As for the San Diego Region, the NELs for the Chollas Creek watershed for zinc, copper, and lead do not go into effect until October 22, 2028. One reason why these effective dates are important to the building and construction industry is that until those effective dates kick-in, we would not be open to third-party lawsuits.

The newly adopted permit does include new provisions that will add costs to the compliance of the permit. AGC will be working on organizing training sessions for contractor staff to understand the new permit procedures, costs and reporting requirements.



Labor Shortage is Problem Number One

Recent analysis from AGC of America shows that the construction industry across the country and in California is still expanding, but there are some headwinds ahead due to the

likelihood of a recession, on-going inflation, and high interest rates along with the threat of more rate increases. A shortage of skilled labor is back as top concern that seems to be contradicted by government mandates that further restrict availability.

Using February 2020 as a pre-pandemic benchmark, Bureau of Labor statistics tell us that commercial, industrial, and infrastructure construction are still down about 2.5% but have risen almost 12% in work volume since the bottom fell out in April 2020. Residential construction has grown significantly across the country and is at almost 7% higher in construction volume than the pre-pandemic days prior to early 2020. But this appears to be ready for a change as the Fed continues to jack up interest rates.

Prices have been mixed, but contractors seem to have changed their approach to bidding. From September 2020 to September 2021, contractors only raised their bid prices about 5% according to the Bureau of Labor Statistics. Meanwhile, the aggregate wholesale prices of construction commodities rose by 20-25% putting major financial strain on many firms. However, since then bid prices have risen about 20% reflecting that contractors are having to pass along the inflation that has occurred due to supply chain disruptions and rising fuel costs among other factors. Wholesale prices of construction commodities are mixed but as a whole look like they have peaked and now fallen off by double digit percentages.

Since the start of the pandemic in early 2020, some commodities' wholesale prices have steadily risen. Others have had radical swings in price. Some examples of wholesale percentage of price increases are as follows for important construction commodities:

Commodity	% change since April 2020	Peak % change since April 2020
Steel Products	103%	140%
Lumber/Plywood	53%	120%
Copper and Brass	55%	79%
Gypsum Materials	49%	Steady Rise
Aluminum	36%	60%
Truck Transportation	36%	Steady Rise
Bid Price (non-resid.)	25%	Up since Sept. 2021

It is no wonder that contractors have had to raise their prices and we would expect that to continue. This will likely factor into a short-term slowdown of some construction as owners take a wait and see approach on the cost of construction in the near term. AGC America reports that a slowdown is likely in homebuilding, warehouse, retail, office and lodging construction.

This comes on the heels of a very good year behind us. According to the U.S. Census Bureau, we have had a mixed bag of construction spending during the period of July 2021 to July 2022.

Utility construction such as electric, oil, gas fields, and pipelines were down collectively 12% most likely due to government policy across the country. Warehouse and retail construction was up 13%. Highway and street construction rose a modest 5%, while manufacturing construction is booming, up 19%.

The three major hikes in federal spending may have little impact in the short run on the fortunes in the construction industry. Why? Because the federal government is not very nimble, and puts in place regulations that hurt the very people they are trying to help.

The Infrastructure Investment and Jobs Act (IIJA), the "Chips" Act (semiconductor manufacturing subsidies) and the *Inflation Reduction Act* collectively are adding historic bumps in theoretical federal spending. However, we already are seeing with the IIJA that the strings attached to the funds are slowing down construction awards and actual spending of federal dollars. Environmental clearance hurdles, *Buy America* provisions and now the latest, restrictive labor provisions, are likely to be added to federal construction projects.

Materials costs and lead times for some materials continue to challenge owners and contractors across the country and here in California. However, labor availability has resumed to be the number one challenge for contractors. 100% of contractors, in a recent survey, have said that they are having trouble filling hourly craft worker positions for crafts such as electricians, mechanics, millwrights, pipelayers, plumbers, and traffic control personnel. Two thirds of contractors in California report that they are having trouble filling any type of craft worker position.
